Good Morning Manor College Students!

I have great news! On March 11, 2021, the American Rescue Plan was signed into law. This created the third Higher Education Emergency Relief Fund (HEERF III). We will refer to this as a third round of CARES Emergency Aid grants to students or CARES 3 Student Emergency Aid Grants. This has provided Manor College with the opportunity to award additional emergency financial aid grants to our students who have exceptional financial need.

Our determination of those students who have this financial need is based on PELL eligibility. For those students who were PELL eligible in our Spring 2021 semester, we will be working on disbursing the CARES 3 Emergency Financial Aid grants as soon as possible.

In order for our Spring 2021 PELL eligible students to receive these refunds, they MUST complete the attached Google form <u>NO LATER THAN 6/25/2021</u> acknowledging that the funds will be spent only on eligible expenses such as those to help you cope with COVID-19 related educational needs incurred due to the change in learning, childcare, housing, food, healthcare, technology and other essential needs that you now face due to the pandemic. Without a completed google form for you verifying that you understand the allowable uses of the funds, we will not be able to process a payment to you so please be sure to complete the form on time so that we have the necessary support we need to send you the CARES 3 refunds.

Manor College has detailed below our plan for the disbursement of the CARES 3 Emergency Funds to our students.

CARES 3 funding is to be given to students with the most exponential financial need. Our measure for financial need is based on Pell eligibility and will be distributed as listed below:

• Full Time Pell Students: 85% of funds divided by number of Full Time Pell students and allocated to each (not to exceed Pell maximum)

• Part Time Pell Students: 15% of funds divided by number of Part Time Pell students and allocated to each (not to exceed Pell maximum)

Manor College will use this formula for funding to be distributed as soon as possible for the Spring 2021 PELL eligible students who complete the below Google Form by 6/25/2021.

We thank you all for continuing to be #ManorStrong and we hope that this funding can help you through these difficult and challenging times.

Funds will be distributed to you the same way we distribute account refunds, through our third party provider. ECSI is our third party provider. Many of you have already registered with ECSI to receive your regular College refunds. We ask that all of you register or check your account through ECSI by 6/25/2021 to update your address on file and add direct deposit information if you desire. You should update your information at https://heartland.ecsi.net/ as soon as possible to verify your updated address, contact, and banking information.
